- 1. PWD Truelove reported that he had received the results of the Manganese testing of the City's water and the results were lower than expected at .421 mg/L. The EPA limit of .30 mg/L was listed on the result report however the EPA has not set an official limit yet.
- 2. PWD Truelove reported that the City Crew would continue to haul off the large snow piles around town. PWD Truelove stated that he would be hiring an additional dump truck to help with the snow removal.
- 3. PWD Truelove reported that there were two water breaks on private water lines on Christmas and he was called out to turn the water off.
- 4. PWD Truelove reported that there had been an incident with a dog running at large and the law enforcement K-9.
- 5. PWD Truelove asked Council's permission to attend the Montana Rural Water Convention in Great Falls in March.
